CONNERS RESTAURANT

Situated on the first floor of the main building, Connors enjoys stunning views over our picturesque Resort Grounds. The room leads out to the balcony which can be used for drinks or fresh air and the adjacent bar area boasts an inviting open fire place in winter.

Connors can comfortably seat a maximum of 120 people on round tables.

Access to the Restaurant is available from 10.30am on the day of your wedding, and we are pleased to offer The Gallery for your deliveries, storage & basic set-ups on the day prior.

Note: *A minimum booking of 15 accommodation rooms is required for Wedding Receptions held in Connors Restaurant.*

CLARE CONVENTION CENTRE – Inchiquin Room

The Inchiquin Room is located in the stand alone Convention Centre situated south of the main complex on the edge of our picturesque resort grounds. With dedicated entrance foyer for meeting & greeting your wedding guests and featuring an adjacent undercover pavilion area, this venue is only available for Cocktail Weddings, up to a maximum of 150 people.

INTIMATE DINING ROOM

CLARE COUNTRY CLUB – WEDDING RECEPTION TERMS & CONDITIONS

The **Clare Country Club (CCC)** takes pride in its facilities, service and professionalism, and its people, who strive to ensure the success of your event. To ensure the satisfaction of all guests, the following terms and conditions are applicable to your event. All bookings are made upon, and are subject to, these terms and conditions.

Deposit/s

The Room Hire Fee is required as a deposit to secure your Wedding Reception at CCC. CCC would be pleased to hold a tentative booking for a maximum of 14 (Fourteen) days. We suggest you undertake a complete site inspection of the property prior to confirming your booking. A draft running sheet of your event must be agreed upon prior to the deposit being paid. Any deposit will be credited against the total amount of your final invoice. In the event of a cancellation, the deposit is non-refundable. A signed copy of these Terms & Conditions must be returned to the Functions Coordinator with the deposit.

For accommodation bookings, a deposit of \$75.00 (Seventy-Five Dollars) per room is required to guarantee individual reservations.

Arrival & Departure

Guests are welcome to check-in anytime after 2.00pm. We are more than happy to check you in prior to 2.00pm if the room is available. Early check in fees may apply. Guests must check out by 10.30 am. Late check-out fees may apply.

Babysitting

Unfortunately, CCC is no longer able to supply a babysitting service. Own arrangements are accepted at own liability.

Labour Charges & Public Holiday Surcharge

General cleaning is included in the room hire. Additional cleaning charges may be incurred where an event has created cleaning requirements to be over and above normal general cleaning. Any event continuing beyond the confirmed departure time will incur a labour surcharge. Similarly, no charge is applicable should you wish to setup your reception yourself, however, should you require CCC staff to assist with set-up for your reception or to help breakdown, a labour charge will apply.

A labour surcharge of \$400 (Four Hundred Dollars) applies to all wedding receptions held on a South Australian or National Public Holiday or Long Weekends.

Payment Policy

Payment of the balance of the function (including all food & beverage packages) is required 14 (fourteen) days prior to the function at the time of confirming final numbers. For any additional incidentals incurred throughout your function, including additional beverage tabs, payment is required at the conclusion of the function. Payment can be made by cheque, cash or credit card.

Price Variations, Pricing & GST

The prices and packages quoted in this Wedding Kit are valid until 30 June 2012. All rates are given in Australian dollars and are inclusive of Goods and Services Tax (GST) as defined in A New Tax System (Goods and Services) Tax Act 1999.

Cancellations

The following cancellation fees may apply if you cancel your function(s) or part thereof:

- ☞ **Confirmed booking & deposit paid** – all deposits paid will be forfeited
- ☞ **With less than 1 months notice** – all deposits paid will be forfeited and you must pay an additional 25% of the estimated total function cost (unless the function room is re-booked in which case CCC, in its discretion, may waive part of the cancellation fee)
- ☞ **With less than 14 days notice** – all deposits paid will be forfeited and you must pay the estimated total function cost (unless the function room is rebooked in which case CCC, in its discretion, may waive part of the cancellation fee)

Catering & Guest Number Confirmation

To ensure the efficient running of your event we require:

- ☞ All menu selections to be confirmed 1 (one) month prior to your function
- ☞ All catering numbers to be confirmed no later than 14 (fourteen) days prior to your function. This is the minimum number of guests that catering will be charged for, even in the event that fewer guests attend.
- ☞ A minimum number of 15 (Fifteen) accommodation rooms are to be guaranteed for Receptions in Connors Restaurant. A \$75.00 (Seventy-Five Dollar) deposit is required per room held. Should the accommodation rooms reduce lower than the agreed 15 rooms, the remaining amount will be charged to the function account.
- ☞ CCC retains the right to provide all catering on the premises, and no food or beverages may be brought onto the premises unless prior permission from management has been obtained.

CCC Responsibility

As your hosts we take every possible care, however we are not responsible for the damage or loss of any merchandise, belongings or food brought onto the premises before, during or after the event.

CLARE COUNTRY CLUB – WEDDING RECEPTION TERMS & CONDITIONS

Function Details

Prior approval from CCC is required for:

- ☞ All plans for decorations that you propose to use during your event. These must be provided for approval by the Functions Coordinator at least 14 (Fourteen) business days before your event.
 - ☞ Attaching anything by nail, screws, adhesive etc, to any part of the property.
- ☞ The use of smoke machines, special balloon effects and/or pyrotechnics (due to the effect on smoke detectors etc).
 - ☞ Any deliveries to the CCC. All deliveries must be marked with the name and date of the function.

Indemnity

You are responsible for and must indemnify CCC for:

- ☞ Loss or damage to CCC arising out of your use.
- ☞ Loss or damage to CCC arising out of any person attending the event.
- ☞ Any additional cleaning requirements that management deems to be in excess of general cleaning duties.
- ☞ Claims by any person regarding loss, damage, injury or death arising out of your use or any other person/s attending the event.

Conduct of the Function

Unless otherwise agreed by CCC, your event must finish at the time specified. Your event must be conducted in an orderly & lawful manner. CCC reserves the right to end your event if CCC reasonably believes that your event is not being conducted in an orderly and lawful manner. CCC has no responsibility to you for costs, damages or expenses that you incur in relation to the CCC's termination of your event. CCC may remove or deny entry to anybody being disruptive or acting in a disorderly manner. You are not permitted to exceed any noise level, which in the opinion of CCC may disturb other guests or disrupt operation of CCC.

Terms & Agency

Unless otherwise agreed, the party which signs these terms & conditions will be the party responsible for the payment of the event charge. Certain Functions may require specific guidelines that are not contained above. Whilst every attempt has been made to cover these, the Functions Coordinator will highlight any additional concerns. Please read these terms & conditions carefully. If you do not understand any of these terms or have any questions, please discuss them with the Functions Coordinator or Manager. If you have read and understood the event and accommodation Terms & Conditions set out above, and accept them, please sign the terms below. In signing the terms, they are binding upon you. Please keep a photocopy for your records.
